

# CANCELATION & PAYMENT POLICIES

## One-Time Training Payment Policies

### Cancelations & Refunds:

A full refund will be given if the refund is requested at least 60 days before the training event.

A 50% refund will be given if the refund is requested at least 45 days before the training event.

A 25% refund will be given if the refund is requested at least 30 days before the training event.

No refund will be given if registration is canceled within 30 days of the training event.

## Level 2 Training Payment Policies

### Payment to Reserve a Spot in a Warriors at Ease Training

In order for a participant to hold their spot in Level 2 training events, payment in full for the Warriors at Ease Level 2 Training is required within 7 business days of an approved Warriors at Ease Level 2 Training Application.

### Cancelations & Refunds for Payments Received Before Application Approval

A full refund will be given if the refund is requested at least 45 days before the training event.

A 75% refund will be given if the refund is requested at least 30 days before the training event.

A 50% refund will be given if the refund is requested at least 15 days before the training event.

No refund will be given if the refund is requested within 15 days of the training event.

### Cancelations & Refunds for Payments Received After Application Approval

A full refund will be given if the refund is requested at least 60 days before the training event.

A 50% refund will be given if the refund is requested at least 45 days before the training event.

A 25% refund will be given if the refund is requested at least 30 days before the training event.

No refund will be given if registration is canceled within 30 days of the training event.

## TEACH Program Payment Policies

Teachers who are enrolled in the 'TEACH' Program are required to adhere to the following expectations for classes to qualify for payment:

1. Have an up-to-date 1099 on file with the Warriors at Ease accounting department.
2. Sign and agree to the Warriors at Ease Teacher Code of Conduct and Ethics.
3. Log attendance for class within 24 hours of teaching the class.
4. Register new students using the New Student Registration Form (electronic or physical).

## Retreat & Event Payment Policies

### Civilian Participants

Civilian spots will not be reserved until payment for accommodations has been paid for in full.

### Veterans & Service Member Participants

Veterans and service members will be required to put down a \$200 deposit in order to reserve a spot in our retreats. The deposit will be refunded in full after the conclusion of the retreats. Please allow 7-10 days for payment processing.

### Cancelations & Refunds:

A full refund will be given if the refund is requested at least 60 days before the event.

A 50% refund will be given if the refund is requested at least 45 days before the event.

A 25% refund will be given if the refund is requested at least 30 days before the event.

No refund will be given if registration is canceled within 30 days of the event.

## Warriors at Ease Cancellation Policy

If Warrior at Ease cancels an event Warriors at Ease will refund participants for the amount paid to Warriors at Ease for event registration. Warriors at Ease will not reimburse participants for cost above and beyond registration paid directly to Warriors at Ease; airfare, car rental, hotel, etc.

Warriors at Ease will do its best to provide a minimum of 60 days' notice if an event is canceled.
