

## PAYMENT POLICY, TERMS & CONDITIONS

*All training payment notices and invoices are delivered via email, and are due upon designated "Due Date" (payments in full) or upon receipt (payment plans).*

### One-Time Training Payment Policy

#### Cancelations & Refunds:

A full refund will be given if the refund is requested in writing at least 60 days before the start of the training event.  
 A 50% refund will be given if the refund is requested in writing at least 45 days before the start of the training event.  
 A 25% refund will be given if the refund is requested in writing at least 30 days before the start of the training event.  
 No refund will be given if registration is canceled in writing within 30 days of the training event.

### Level 2 & Combined Training Payment Policy

#### **Training Registration Confirmation**

To confirm training registration payment in full is required within 7 business days of an approved Training Application.

#### **Training Payment Plan**

*Level 2 Training Application must be received a minimum of 5 months prior to the start of the selected training date in order to satisfy payment in full and timely completion of the Level 2 Training Pre-work (16 Hours).*

#### Level 2 Training (Through April 30th, 2021)

\$100 Non-refundable Deposit  
 \$150 First Payment  
 \$150 Second Payment  
 \$95 Final Payment

#### Combined Training (Through 30th, April 2021)

\$200 Non-refundable  
 \$350 First Payment  
 \$350 Second Payment  
 \$300 Final Payment

#### Level 2 Training (Beginning May 1st, 2021)

\$100 Non-refundable Deposit Due Upon Receipt  
 \$150 First Payment  
 \$150 Due within 60 Days of Invoice  
 \$175 Due within 90 Days of Invoice

#### Combined Training (Beginning May 1st, 2021)

\$200 Non-refundable Deposit Due Upon Receipt  
 \$350 Due within 30 Days of Invoice  
 \$350 Due within 60 Days of Invoice  
 \$300 Due within 90 Days of Invoice

#### **Cancelations & Refunds for Payments Received Before Application Approval**

A full refund will be given if the refund is requested in writing at least 45 days prior to the start of the training event.  
 A 75% refund will be given if the refund is requested in writing at least 30 days prior to the start of the training event.  
 A 50% refund will be given if the refund is requested in writing at least 15 days prior to the start of the training event.  
 No refund will be given if registration is canceled in writing less than 15 days prior to the start of the training event.

#### **Cancelations & Refunds for Payments Received After Application Approval**

A full refund will be given if the refund is requested in writing at least 60 days prior to the start training event.  
 A 50% refund will be given if the refund is requested in writing at least 45 days prior to the start training event.  
 A 25% refund will be given if the refund is requested in writing at least 30 days prior to the start training event.  
 No refund will be given if registration is canceled in writing less than 30 days prior to the start of the training event.

### Transfer & Reschedule Policy

Trainees who need to transfer their enrollment payment to a different scheduled training may differ a maximum of two times. Once trainees have requested a registration transfer, registration payments are non-refundable. If trainee requests the training enrollment and payment be transferred for a third time, trainees will be required to pay a transfer fee of \$150 each time a registration transfer is requested after the allotted two transfers.

### **TEACH Program Payment Policies**

Teachers who are enrolled in the 'TEACH' Program are required to adhere to the following expectations for classes to qualify for payment:

1. Have an up-to-date 1099 on file with the Warriors at Ease accounting department.
2. Sign and agree to the Warriors at Ease Teacher Code of Conduct and Ethics.
3. Log attendance for class within 24 hours of teaching the class.
4. Adhere to the Warriors at Ease Class and Teacher Specifications Policy.

### **Retreat & Event Payment Policies**

#### Cancelations & Refunds

A full refund will be given if refund is requested in writing at least 60 days prior to the start of the event.

A 50% refund will be given if refund is requested in writing at least 45 days prior to the start of the event.

A 25% refund will be given if refund is requested in writing at least 30 days prior to the start of the event.

No refund will be given if cancelation is received in writing less than 30 days prior to the start of the training event.

### **Warriors at Ease Cancelation Policy**

If Warrior at Ease cancels an event Warriors at Ease will refund participants for the amount paid to Warriors at Ease for event registration. Warriors at Ease is not responsible for reimbursement to participants for costs above and beyond registration paid directly to Warriors at Ease; ex: airfare, car rental, hotel, etc.

Warriors at Ease will do its best to provide a minimum of 60 days' notice if an event is canceled due to unforeseen circumstances and/or events beyond our control.
